

# Affidavit of Acknowledgement of the SHYC Declaration, Covenant Restrictions, Rules and Regulations

The **Snug Harbor Declaration** is a legal document filed with the Martin County Court that establishes its existence and further governs the use and maintenance of condominium property through the actions of its Board of Governors. Use and maintenance includes not only common areas, but in our case it also **defines owner responsibilities** (**financial and otherwise**) **and limits what owners may do with their property**. You are being provided with a current copy of the Declaration and by your signatures affirm that you have read and understood it, and have had an opportunity to ask questions in a meeting with the New Member Committee and Board members that took place on

Your attention is directed to pages 4-5 where the one-time **capital contribution**, as well as annual and special assessments is defined. Attention is further directed to section 4 (page 6): **Building**, **Use Restrictions and Covenants**. In short, this section requires that any change to the existing buildings or structures (defined in Declaration Exhibit F) on the property must be approved by the recommendation of the Architectural Review Committee and then by the Board of Governors. The placement of fences, the height of a home, the area of any guest house, signage, and the use and rental of the property by the owner are among the things that are restricted or regulated. Furthermore, **Snug Harbor Yacht Club does not allow construction of any type to occur within the setbacks**, which are defined for each property in the Declaration's Exhibit E.
